Trustees:

The Employee Retirement Income Security Act of 1974 (ERISA) and Department of Labor regulations require employee benefit plans filing annual report Form 5500 with the Employee Benefits Security Administration to furnish participants and beneficiaries with a summary annual report. This summary annual report must be furnished within two months after Form 5500 is due. In the case of your Plan, it must be furnished by April 15, 2024.

The summary annual report must be sent to all participants and beneficiaries by a method likely to result in full distribution. SUMMARY ANNUAL REPORT FOR

ELECTRICAL WORKERS LOCAL NO. 292 DEFINED CONTRIBUTION AND 401(K) PLAN

This is a summary of the annual report of Electrical Workers Local No. 292 Defined Contribution and 401(k) Plan, EIN 41-1760754, for the year ended April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Plan expenses were \$39,482,331. These expenses included \$1,316,801 in administrative expenses and \$38,165,530 in benefits paid to participants and beneficiaries. A total of 6,055 persons were participants in or beneficiaries of the Plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

Benefits under the Plan are provided by a trust.

The value of plan assets, after subtracting liabilities of the Plan was \$994,743,187 as of April 30, 2023, compared to \$986,157,826 as of May 1, 2022. During the plan year, the Plan experienced an increase in its net assets of \$8,585,361. This increase included unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$48,067,692 including, but not limited to, employer contributions of \$27,830,228; participant contributions of \$12,329,151; rollover contributions of \$194,003; gains of \$1,409,797 from the sale of assets, earnings from investments of \$5,988,149; and other income of \$316,364.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
